## Payment Information & Schedule

1. An initial \$600 down reserves your wedding date. This fee is non-refundable, but may be refunded only at the discretion of Kzoom Video Solutions.
2. The remaining balance is due upon pick-up or delivery of your finished project (approx. 1-2 months after wedding).

## Contractual Agreement

It is understood that Kzoom retains the right to display footage of client's wedding day for demonstration purposes. In the event of an editing error on the final wedding video (ex. A misspelled name), Kzoom will provide new VHS and DVD copies of the wedding. Requests to change editing decisions, however, will be billed at Kzoom's hourly rates.
